

WHAT IS THE GOAL OF THIS CAMPAIGN?

We want more solidarity organizations, businesses, and faith groups to declare themselves “apartheid free.” Since 2021, three major human rights groups, including one Israeli group, have published exhaustive reports accusing Israel of the crime of apartheid against Palestinians. Yet, with taxpayer dollars and political cover, the U.S. government continues to uphold this cruel system of inequality. Declaring your group “apartheid free” would be the first step in dismantling that support and affirming the rights of the Palestinian people, the same rights that should exist for all people.

APARTHEID-FREE PLEDGE TEXT

More than 800 faith-based communities, solidarity organizations, and businesses have taken the following pledge and declared themselves “apartheid-free” as part of the Apartheid-Free Communities initiative. We hope your community will follow this example of principled moral action.

WE AFFIRM

our commitment to freedom, justice, and equality for the Palestinian people and all people; and

WE OPPOSE

all forms of racism, bigotry, discrimination, and oppression; and

WE DECLARE

ourselves an apartheid-free community, and to that end,

WE PLEDGE

to join others in working to end all support to Israel's apartheid regime, settler colonialism, and military occupation.

WHAT IS *APARTHEID*?

Apartheid is one frame through which to examine the actions taken by the Israeli government and the systems and structures perpetuating inequality and violence against Palestinians. The apartheid frame can help one see the oppression of Palestinians as both a civil rights issue and a racial justice issue. Military occupation and settler colonialism are two other frames through which to understand violence against Palestinians. They are both mentioned in the apartheid-free pledge language.

LEGAL
DEFINITION



Apartheid is defined in international law as a crime against humanity that involves “inhuman acts committed for the purpose of establishing and maintaining domination by one racial group of persons over any other racial group of persons and systematically oppressing them.” While the global understanding of apartheid developed based on the official legal policy by that name that existed in South Africa, apartheid can exist anywhere.

APARTHEID *LOOKS LIKE...*

MOVEMENT RESTRICTIONS

A complex system of ID cards, checkpoints, and permits restricts where Palestinians can travel. Palestinians from Gaza live under military blockade and must obtain a permit to leave. Permit applications are often denied or delayed, even for those seeking medical care.

HOME DEMOLITIONS

Israel uses policies including the Absentee Property Law and a building permit system to take over Palestinian-owned land, often for Jewish-only settlements or military training zones.

RESTRICTIONS ON VOTING RIGHTS

Palestinians in the occupied West Bank and Gaza Strip cannot vote in Israeli elections that determine the policies they must then live under.
